There will be a \$50 charge for customer errors resulting in a domain name change. If payment is more than thirty days late, this contract will become null and void and Eagle Web Services, Inc. reserves the right to re-sell the site. All prices are subject to change with sixty days notice.

Domain Names: Eagle Web Services, Inc. will attempt to obtain a domain name as close to the neighborhood name as possible, but does not guarantee it will be identical. All domain names will become and remain the property of Eagle Web Services, Inc. Eagle Web Services, Inc. warrants that it will not sell a neighborhood site to another customer for the neighborhood being purchased exclusively hereunder.

Templates: I understand these web sites are built from templates and changes are limited.

Editable pages: I understand I may sell advertising, limited to six spots, on the professional services page and can change or delete them at my discretion. Said ads can include one graphic, the company name, phone number, email address, web site URL, and four lines of copy.
